

Armin served as Waseca County Farm Bureau President for four years. In 2006, Farm Bureau of MN awarded them an Honorary Life Membership because of their leadership contributions to Farm Bureau and Rural America.

They will celebrate their 60th wedding anniversary in September 2010. "They have been good years."
